

ORDINANCE NO. 42

AN ORDINANCE ESTABLISHING AND REGULATING A BOARD OF HEALTH IN AND FOR THE BOROUGH; PROVIDING FOR AUTHORITY, DUTIES AND RESPONSIBILITIES; PROVIDING FOR A SECRETARY AND A HEALTH OFFICER AND AMOUNT OF THEIR BONDS.

The Council of the Borough of Monroeville hereby ordains and enacts the following Ordinance:

SECTION 1. A Board of Health is hereby created and established in and for the Borough of Monroeville in accordance with the Provisions of Article 32 of the Borough Code, under the Act of 1947 P.D. 1621, 53 P.S. 15205. The Board of Health shall have general supervision over sanitary conditions in the Borough and shall perform all the duties, shall have all the authority and may exercise all the powers vested by law in the Board of Health in the Borough and such additional powers and authority as shall be authorized by Ordinances of the Borough.

SECTION 2. The members of the Board of Health shall be appointed by the Borough Council in the manner provided by law, as soon as is practicable after the adoption of this Ordinance and the said appointees shall take and hold office as shall be directed by the Borough Council. It shall be the duty of the Borough Council to maintain the Board of Health at full membership by appointment of new members as shall be necessary to fill vacancies caused by the expiration of terms, death, removal from the Borough or other causes.

SECTION 3. The Board of Health shall meet regularly at a stated time and place in accordance with rules and regulations established by the Board of Health, at least once a month, and shall hold such other special meetings as the health conditions of the Borough may require. The said Board shall hold its annual organization meeting in the month of March, at which time officers for the ensuing year, as prescribed by law, shall be elected.

SECTION 4. If any member of the Board of Health shall fail to attend the stated meetings of the Board of Health, without sufficient cause or without having been excused from attendance thereat by the Board of Health, or shall otherwise neglect his duties as a member of said Board for a period of three (3)

months, he shall be considered to have resigned and withdrawn from the membership of the Board of Health and the Borough Council shall proceed to fill the vacancy thus created.

SECTION 5. The Secretary of the Board of Health shall, during his or her term of office, be a duly constituted member of the Board of Health. The Secretary of the Board of Health and the Health Office shall each give bond, with corporate surety, to the Borough, in the sum of Five Hundred (\$500.00) Dollars, for the faithful discharge of their respective duties.
