

ORDINANCE NO. 96

PROVIDING FOR THE TRANSFER OF FIFTEEN THOUSAND FOUR HUNDRED DOLLARS (\$15,400.00) FROM THE 1956 BOND FUND TO THE SEWER FUND: DECLARING THE CONSTRUCTION OF STREETS AND STORM SEWERS TO BE IMPRACTICAL AND INADVISABLE FOR A PERIOD OF FOUR (4) MONTHS AND PROVIDING FOR THE RETURN OF SAID TRANSFERRED FUNDS.

BE IT ORDAINED AND ENACTED by the Burgess and Council of the Borough of Monroeville, and it is hereby ordained and enacted by the authority of the same:

SECTION ONE: That as of September 1, 1956, the debt of the Borough of Monroeville was increased, without the assent of the electors in the sum of Four Hundred Eighty Thousand (\$480,000.00) Dollars for the declared purposes, the erection of a municipal building and the furnishing thereof and the construction of streets and storm sewers.

SECTION TWO: The judgment of the Borough Authorities is that it is impracticable and inadvisable to proceed at this time with the complete construction of said streets and storm sewers and, further, that it will be impracticable and inadvisable to do so before the first (1st) day of December, 1957.

SECTION THREE: The Sewer Fund of the Borough of Monroeville needs for the next four (4) months the sum of Fifteen Thousand Four Hundred \$15,400.00) Dollars in order to meet the expenses of construction thereof pending the receipt of connection fees from the owners of the properties specially benefitted by the construction of said sanitary sewers.

SECTION FOUR: The construction of sanitary sewers is a proper municipal function and is one for which the increase in debt of the Borough of Monroeville referred to in Section One of this Ordinance might have been made.

SECTION FIVE: Pursuant to Article II, Section 216 of the Act of June 25, 1941, P.L. 159, commonly known as the "Municipal Borrowing Act", the proper officers of the Borough of Monroeville are hereby authorized and directed to transfer from the 1956 Bond Fund to the Sewer Fund the sum of Fifteen Thousand Four Hundred (\$15,400.00) Dollars.

SECTION SIX: Effective with the first (1st) day of August, 1957, and continuing upon the first (1st) day of each month thereafter, the same said proper officers of the Borough of Monroeville are hereby directed to transfer back from the Sewer Fund to the 1956 Bond fund the total of the receipts, during each month, from sewer connection charges until the total sum of Fifteen Thousand Four Hundred (\$15,400.00) Dollars has been transferred back. This provision shall not apply to the receipts from the School District of the Borough of Monroeville, Tom Mistick Builders, Inc., Urick and Ritchey and Colonial Development Company arising from the Simpson Run and Moss Side Sewers.

SECTION SEVEN: Any Ordinance or part of an Ordinance conflicting with the provisions of this Ordinance is hereby repealed.
