ORDINANCE NO. 133

AN ORDINANCE PROVIDING FOR THE EXECUTION OF AN AGREEMENT BY THE PROPER OFFICERS OF THE BOROUGH OF MONROEVILLE FOR THE BOROUGH OF MONROEVILLE WITH J. W. HARPER AND DORIS HARPER, HIS WIFE FOR THE CONSTRUCTION OF A SANITARY SEWER TRUNK LINE ON SKYLINE AND FAIRLAWN DRIVES.

WHEREAS, J. W. HARPER and DORIS HARPER, his wife, are the owners of fourteen (14) lots located on Skyline and Fairlawn Drives in the Borough of Monroeville and in order to make these said lots usable and salable, it is necessary that a sanitary sewer trunk line be constructed along the said Skyline and Fairlawn Drives in the Borough.

WHEREAS, The Borough of Monroeville is unable to finance the said construction of the said sanitary sewer trunk line and J. W. Harper and Doris Harper, his wife are willing to install and to pay the costs of said construction in accordance with the plans and specifications as prepared by the Borough Engineer.

BE IT ORDAINED AND ENACTED by the Council of the Borough of Monroeville and it is hereby ordained and enacted by the authority of the same that:

SECTION 1. The proper officers of the Borough are hereby authorized and directed to enter into an Agreement with J. W. Harper and Doris Harper, his wife for the construction of a sewer trunk line located on Skyline and Fairlawn Drives in the Borough of Monroeville.

SECTION 2. In consideration of said construction at the sole cost and expense of J. W. Harper and Doris Harper, his wife, the Borough of Monroeville shall issue to J. W. Harper and Doris Harper, his wife, fourteen (14) sewer tap permits which may be used by the said J.W. Harper

and Doris Harper, his wife, for the fourteen (14) lots which they now own and have developed or intend to develope. In addition thereto, the Borough of Monroeville shall reimburse J. W. Harper and Doris Harper, his wife the sewer tap fees which shall be collected by the Borough from seven (7) residences now located along the said sewer trunk line, which sewer taps have been assessed in the sum of Three Hundred Fifty (\$350.00) Dollars per tap or a total of Two Thousand Four Hundred Fifty (\$2,450.00)Dollars. The Borough shall have no obligation for the payment of the said seven (7) sewer taps and shall be paid by the Borough to J. W. Harper and Doris Harper, his wife when the said tap fees are collected from the present property owners.

SECTION 3. Any Ordinance or part of an Ordinance that shall conflict with this Ordinance is hereby repealed to the extenet of the said conflict.
