ORDINANCE NO. 203

AN ORDINANCE PROVIDING FOR THE EXECUTION OF A CONTRACT BY THE PROPER OFFICERS OF THE BOROUGH OF MONROEVILLE FOR THE BOROUGH OF MONROEVILLE WITH JOHN RANGOS FOR THE SUPPLYING OF THREE THOUSAND TONS OF CINDERS BY JOHN RANGOS TO THE BOROUGH AND THE PAYMENT BY THE BOROUGH TO JOHN RANGOS OF TWO DOLLARS FORTY-FIVE CENTS (\$2.45) PER TON FOR CINDERS DELIVERED TO THE BOROUGH STOCK PILE OR ONE DOLLAR NINETY-FIVE CENTS (\$1.95) PER TON FOR CINDERS PICKED UP IN THE BOROUGH TRUCK AND LOADED BY RANGOS: FURNISHING OF PROPER BOND, WORKMEN'S COMPENSATION POLICY, FILLING BY RANGOS OF A STATEMENT OF MINIMUM WAGES PAID AND AGREEING NOT TO DISCRIMINATE ON ACCOUNT OF RACE, COLOR OR CREED OR SUFFER PENALTY.

BE IT ORDAINED AND ENACTED by the Council of the Borough of Monroeville and it is hereby ordained and enacted by authority of the same that:

Section 1. Upon the opening of bids for the supply of three thousand tons of cinders according to the specifications contained in the advertisement, it appearing that the lowest responsible bidder for supplying this material was John Rangos whose bid was two dollars forty-five cents (\$2.45) per ton for cinders delivered to the Borough stock pile or one dollar ninety-five cents (\$1.95) per ton for cinders picked up in the Borough truck and loaded by John Rangos.

Section 2. The proper officers of the Borough are hereby authorized and directed to enter into a contract with the said John Rangos for the supplying of the aforesaid cinders for the sums hereinbefore mentioned.

Section 3. Before the aforesaid contract shall be executed, the said contractor, John Rangos, shall have filed with the Borough Secretary a performance bond in the amount of _____, a labor and materialmen's bond in the amount of _____ and a policy covering workmen's compensation liability.

Section 4. The contract shall contain a statement of minimum wages paid by John Rangos and contain a promise not to discriminate on account of race, creed or color or suffer penalty.

Section 5. ANY Ordinance or part of an Ordinance that shall conflict with this Ordinance is hereby repealed to the extent of said conflict .
