BOROUGH OF MONROEVILLE ORDINANCE NO. 211

AN ORDINANCE OF THE BOROUGH OF MONROEVILLE ACCEPTING THE DEDICATION OF MATTERHORN ROAD IN SAID BOROUGH FROM ITS INTERSECTION WITH THE CENTER LINE OF ALPINE VILLAGE PLAN OF LOTS NO. 1, AND ALPINE VILLAGE DRIVE FROM ITS INTERSECTION WITH WILLIAM PENN HIGHWAY TO THE SOUTHERLY LINE OF LOT NO. 260 IN ALPINE VILLAGE PLAN OF LOTS NO. 2, AND DECLARING THE SAME TO BE PUBLIC HIGHWAYS OF SAID BOROUGH.

WHEREAS, it appears by certificate of the Borough Engineer of said Borough that the construction of Matterhorn Road and Alpine Village Drive, in accordance with their plans and specifications, has been completed.

NOW THEREFORE, be it ordained and enacted by the Borough Council of the Borough of Monroeville, County of Allegheny, Commonwealth of Pennsylvania, and it is hereby ordained and enacted by the authority of the same.

SECTION 1. That the Borough of Monroeville hereby accepts the dedication of Matterhorn Road in Alpine Village Plan No. 1 recorded in the Recorder's Office of Allegheny County, Pennsylvania, in Plan Book Vo! 67 pages 146 to 148 inclusive from its intersection with Alpine Village Drive to its terminus in a cul-de-sac at Lot No. 127 in said plan and declares the same to be a public highway of said Borough.

SECTION 2. That the Borough of Monroeville hereby accepts the dedication of A Alpine Village Plan No. 1 recorded in the Recorder's Office of Allegheny County, Pennsylvania, in Plan Book Vol.67, pages 146 to 148 inclusive and in Alpine Village Plan No. 2 recorded in the Recorder's Office of Allegheny County, Pennsylvania, in Plan Book V . 68, pages 69 yo 74 inclusive from its intersection with William Penn Highway, in said Borough, to the southerly line of Lot No. 260 in said Alpine Village Plan No. 2 and declares the same to be a public highway of said Borough.

SECTION 3. All Ordinances or parts of Ordinances conflicting with the provisions of this Ordinance are hereby repealed to the extent of such conflict.
