

BOROUGH OF MONROEVILLE  
ORDINANCE NO. 217

AN ORDINANCE PROVIDING FOR THE EXECUTION OF A CONTRACT BY THE PROPER OFFICERS OF THE BOROUGH OF MONROEVILLE FOR THE BOROUGH WITH NORWIN CONSTRUCTION COMPANY FOR THE SUPPLYING TO THE BOROUGH BY NORWIN CONSTRUCTION COMPANY OF CERTAIN MATERIALS AND LABOR FOR THE SURFACING, GRADING AND REPAIRING OF ROADS AND STREETS IN THE BOROUGH OF MONROEVILLE FOR THE SUMS IN ACCORDANCE WITH BIDS ON SPECIFICATIONS DATED JUNE, 1960, AS PREPARED BY THE CONSULTING ENGINEER AND PROVIDING FOR THE POSTING OF NECESSARY BONDS AND INSURANCE POLICIES.

BE IT ORDAINED AND ENACTED by the Council of the Borough of Monroeville and it is hereby ordained and enacted by the authority of the same that:

SECTION 1. On the opening of the bids for the supplying of material and labor for the grading, surfacing and repairing, it appearing that the lowest responsible bidder for the doing of this work was Norwin Construction Company whose bid is in accordance with the specifications dated June, 1960, as prepared by the consulting Engineer and providing for the posting of necessary bonds and insurance policies.

Section 2. The proper officers of the Borough are hereby authorized and directed to enter into a contract No. 1, 2, 3, and 4-R in accordance with the specifications dated April, 1960, as prepared by the consulting Engineer, providing for the supply of the material and labor and the posting of necessary bonds and insurance policies and numerous other provisions with the said Norwin Construction Company for the sums in accordance with the bids on specifications dated June, 1960, as prepared by the consulting Engineer and providing for the posting of necessary bonds and insurance policies.

SECTION 3. Before the aforesaid contract shall be executed, the said contractor, Norwin Construction Company, shall file, with the Borough Secretary, a performance bond for \$368,660.00, a labor and materialmen's bond in the amount of \$368,660.00, a maintenance bond on the amount of \$55,299.00 and insurance policies covering personal injury, property damage and workmen's compensation liability.

Section 4. Any Ordinance or part of an Ordinance that shall conflict with this Ordinance is hereby repealed to the extent of the said conflict.
