

BOROUGH OF MONROEVILLE  
ORDINANCE NO. 256

AN ORDINANCE AMENDING ORDINANCE NO. 180 OF THE BOROUGH OF MONROEVILLE, ENACTED APRIL 12, 1960 AND ENTITLED "AN ORDINANCE FIXING THE SALARIES AND COMPENSATION OF THE OFFICERS AND EMPLOYEES OF THE BOROUGH OF MONROEVILLE FOR THE YEAR 1961, AND PROVIDING FOR HOLIDAYS.

BE IT ORDAINED AND ENACTED BY THE COUNCIL OF THE BOROUGH OF MONROEVILLE, Allegheny County, Pennsylvania, and it is hereby ordained and enacted by the authority of the same.

SECTION 1. That Section 1 of Ordinance No. 180 of the Borough of Monroeville, ordained and enacted on the 12th day of April, 1960, be amended to read as follows;

SECTION 1. The officers and employees to conduct the business and affairs of the Borough in accordance with the requirements fixed by law, ordinance or resolution, together with their compensation for the year 1961, shall be as follows:

SECTION 2. No Borough employees shall be required to report for work or perform any work on the following days:

Fourth of July

New Year's Day

Memorial Day

Thanksgiving Day

Christmas Day

Labor Day

In addition, road employees shall be excused from duty on Washington's Birthday, office employees shall be excused from duties on Good Friday, and the Police shall be excused from duty on Easter.

Should any of the foregoing persons be required to work on a day for which they have been excused that employee shall be compensated at twice the normal amount of pay for a regular day.

SECTION 3. This Ordinance shall be effective 1-1-61.?

SECTION 4. All ordinances or parts of ordinances conflicting with this ordinance are hereby repealed.
