

BOROUGH OF MONROEVILLE  
ORDINANCE NO. 266

AN ORDINANCE OF THE BOROUGH OF MONROEVILLE, ALLEGHENY COUNTY, PENNSYLVANIA, AUTHORIZING AND DIRECTING THE CONSTRUCTION OF A SANITARY SEWER THROUGH THE LAND OF EDWARD S. KRIVACSY AND RUTH KRIVACSY, HIS WIFE, BY CONTRACTORS DEVELOPMENT, INC., PROVIDING FOR THE COST OF THE CONSTRUCTION THEREOF AND THE PAYMENT OF COSTS, DAMAGES AND EXPENSES FOR THE CONSTRUCTION OF SAID SEWER WHICH SHALL BE COLLECTED FROM THE PROPERTY SPECIFICALLY BENEFITED ALONG THE LINE OF SAID SEWER IN THE MANNER AS NOW PRESCRIBED BY LAW.

BE IT ORDAINED AND ENACTED by the Council of the Borough of Monroeville, County of Allegheny and Commonwealth of Pennsylvania; and it is hereby ordained and enacted by and with the authority of same.

SECTION 1. That a sanitary sewer be constructed by Contractors Development, Inc., through the following described property;

Property of Edward S. Krivacsy and Ruth Krivacsy, his wife;

A twenty (20) foot right-of-way in and through that certain lot or piece of ground situate in the Borough of Monroeville, County of Allegheny and Commonwealth of Pennsylvania, the center line of which twenty (20) foot right-of-way is as follows, to-wit:

BEGINNING at a point in the dividing line between land of Edward S. Krivacsy and Ruth Krivacsy and the land of Penn Glenn Oil Company, in or near Abers Creek; thence through said Krivacsy land South 25° 03' West, 265.29 feet.

SECTION 2. That said sewer shall be constructed in accordance with the plans and specifications prepared by Contractors Development, Inc., which said plans are on file in the office of the Borough Manager, Municipal Building, Monroeville, Pennsylvania.

SECTION 3. That the costs, damages and expenses for the construction of said sewer shall be collected from the properties specifically benefited along the line of said sewer in the manner as now prescribed by law.

SECTION 4. That any Ordinance or part of an Ordinance conflicting with the terms of this Ordinance be and the same is hereby repealed.
