

BOROUGH OF MONROEVILLE
ORDINANCE NO. 274

AN ORDINANCE OF THE BOROUGH OF MONROEVILLE, ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING SECTION 1 AND SECTION 2 OF ORDINANCE NO. 164 AND SECTION 2 AND SECTION 6 OF ORDINANCE NO. 159, PROVIDING FOR THE SCHEDULE OF RATES AND PAYMENTS OF SEWER CHARGES OR RENTALS.

BE IT ORDAINED AND ENACTED by the Council of the Borough of Monroeville, Allegheny County, Pennsylvania, and it is hereby ordained and enacted by the authority of the same.

SECTION 1. SCHEDULE OF RATES. Section 1 of Ordinance No. 164 and Section 2 of Ordinance No. 159 shall be amended to read as follows:

a. The service charge for any person, firm, or corporation, owners of residential property discharging sewage into said system shall be based upon the quantity of water used on or in said premises owned as aforesaid, as the same is measured by water meters in use or other meters to be installed and shall be charged quarterly at the following rates:

	WATER USED PER QUARTER YEAR	SEWAGE CHARGE
For first	100,000 gallons	35 cents per 1,000 gallons
For next	1,000,000 gallons	26 cents per 1,000 gallons
For next	2,500,000 gallons	21 cents per 1,000 gallons
For excess over	3,600,000 gallons	16 cents per 1,000 gallons

Subject to a minimum charge of \$3.15 per quarter year.

b. The service charge for any person, firm or corporation, owners of commercial and/or industrial property discharging sewage, industrial waste, water or other liquids into said system shall be based upon the quantity of water used on or in said premises, owned as aforesaid, as the same is measured by water meters in use or other meters to be installed and shall be charged monthly at the following rates:

	WATER USED PER MONTH	SEWAGE CHARGE
For first	33,333 gallons	35 cents per 1,000 gallons
For next	333,333 gallons	26 cents per 1,000 gallons
For next	833,333 gallons	21 cents per 1,000 gallons
For excess over	1,200,000 gallons	16 cents per 1,000 gallons

Subject to a minimum charge of \$1.65 per month.

SECTION 2. Section 2 of Ordinance No. 164 and Section 6 of Ordinance No. 159 shall be amended to read as follows:

ORDINANCE NO. 274

PAYMENTS. Residential sewer charges or rentals shall be paid quarterly and commercial and/or industrial charges or rentals shall be paid monthly, in accordance with bills for sewerage service which shall be rendered or caused to be rendered by the Borough of Monroeville or its duly authorized agent for collection. Charges for sewage services shall be subject to a five per cent penalty if not paid within thirty (30) days after the billing date.

Delinquent payments shall be subject to be liened in accordance with the law.

SECTION 3. All Ordinances or parts of Ordinances conflicting with this Ordinance are hereby repealed.
