

## ORDINANCE NO. 329

## ORDINANCE OF THE BOROUGH OF MONROEVILLE AMENDING ORDINANCE NO. 251, REGULATING THE USE OF SIGNS.

BE IT ORDAINED AND ENACTED by the Borough of Monroeville in Council assembled, and it is hereby ordained and enacted by authority of the same.

SECTION 1. Item 1 of Section 1 of Ordinance No. 251 of the Borough of Monroeville is hereby amended by adding the following sentence at the end thereof:

"The term sign shall further include all articles, matter or devices, whether or not containing lettering or advertising material, which have as their sole purpose the attraction of patrons or calling attention to the business premises. When such articles are arranged in series or strings, such as strings of pennants, each of such articles or pennants shall be treated as a separate sign."

SECTION 2. Section 7 of said Ordinance No. 251 is hereby amended to read as follows:

SECTION 7 - PERMIT FEES --

Every applicant before being granted a construction permit or renewal permit hereunder, shall pay to the Borough the following permit fees for such sign or device regulated by this Ordinance. This fee is for the purpose of providing inspection during construction or erection and continuously thereafter.

ERECTION FEES

For signs under 100 square feet in area - (one side only)	\$10.00
For signs over 100 square feet in area -	\$20.00
For illuminated signs under 100 square feet in area -	\$15.00
For illuminated signs over 100 square feet in area -	\$25.00

RENEWAL FEES

For signs under 100 square feet in area - (one side only)	\$ 5.00
For signs over 100 square feet in area -	\$15.00
For illuminated signs under 100 square feet in area -	\$10.00

For illuminated signs over 100 square feet  
in area - \$20.00

Every permit issued hereunder shall be renewed on or before the 31st day of January of each year for the current calendar year. The annual permit shall be displayed on the lower right-hand corner of the signs. The provisions of this Section shall not become effective until January 1, 1963, and shall not apply to temporary signs.

SECTION 3. Sub-section 3 of Section 14 of said Ordinance No. 251, which exempts signs painted on the exterior surface of buildings is repealed in its entirety.

SECTION 4. Section 21 of said Ordinance No. 251 is hereby amended by adding Sub-section (g) as follows:

(g) Not more than three (3) ground signs shall be permitted for any business establishment, exclusive of signs which are solely used for the direction of traffic of parking; provided, however, that if a business establishment occupies more than five (5) acres of ground, an additional ground sign shall be permitted for each full additional acre of ground.

SECTION 5. Section 25, Sub-Sections (a) and (e) are hereby amended by changing the term for a temporary sign and permit from "Six (6) Months) to a period not exceeding "Two (2) Months".

SECTION 6. Sub-Section (g) of Section 25 of said Ordinance No. 251, is hereby amended to read as follows:

(g) Bond, license or insurance requirements.

No bond or insurance shall be required on temporary signs. However, permits shall be required for each temporary sign at a fee of ONE AND NO/100 (\$1.00) DOLLAR per sign.

SECTION 7. Section 32 of said Ordinance No. 251 is hereby amended to read as follows:

SECTION 32 - PENALTIES --

Any person violating any provision or regulation of this Ordinance shall, after reasonable notice, and upon conviction thereof before any Justice of the Peace, be fined a sum not exceeding ONE HUNDRED AND NO/100 (\$100.00) DOLLARS, and upon default of payment of said fine, may be committed to imprisonment in the Allegheny County Jail for a period not exceeding ten (10) days. Each day that a violation is permitted to exist after written notice has been served by the Borough Manager, shall constitute a separate offense and may be punishable as such hereunder.

SECTION 8. Any Ordinance, or part of Ordinance, which shall conflict with any of the provisions of this Ordinance, are hereby repealed to the extent of such conflict.
