

ORDINANCE NO. 366

AN ORDINANCE OF THE BOROUGH OF MONROEVILLE AUTHORIZING AND DIRECTING THE CONSTRUCTION OF A SANITARY SEWER IN ACCORDANCE WITH PLANS AND SPECIFICATIONS PREPARED AND PROVIDED BY THE BOROUGH OF MONROEVILLE KNOWN AS CONTRACT NO. 6205-S, AND PROVIDING FOR THE EXECUTION OF A CONTRACT FOR THE CONSTRUCTION THEREOF.

BE IT ORDAINED AND ENACTED by the Borough of Monroeville in Council assembled, and it is hereby ordained and enacted by authority of the same.

SECTION 1. That a sanitary sewer line be constructed by the Borough of Monroeville to service certain properties abutting or in the vicinity of Miller Avenue lying wholly within the Borough of Monroeville, all in accordance with and as shown on the plans and specifications of the Borough of Monroeville known as the Miller Avenue Sanitary Sewer Project Contract No. 6205-S.

SECTION 2. That the said sewer line shall be constructed in accordance with the plans and specifications as approved by the Borough Engineer of the Borough of Monroeville which plans are on file in the office of the Borough Manager, Municipal Building, Monroeville, Pennsylvania.

SECTION 3. Upon the opening of bids of the said Sewer Project, Contract No. 6205-S, it appeared that the lowest responsible bidder for the construction thereof was Contractor's Development Company, Inc. whose gross sum bid is \$29,651.30.

SECTION 4. The proper officers of the Borough of Monroeville are hereby authorized and directed to enter into a contract with Contractor's Development Company, Inc. for the construction of the said Sewer Project Contract No. 6205-S, according to the plans, specifications, conditions and agreements therein contained, as established and approved by the Borough Engineer of the Borough of Monroeville for the gross sum of \$29,651.30.

SECTION 5. Upon execution of the said Contract, the said Contractor shall file with the Borough Secretary, a performance bond equal to ONE HUNDRED (100%) PERCENT of the gross sum bid, a labor and materialmen's bond equal to FIFTY (50%) PERCENT of the gross sum bid, a maintenance bond equal to FIFTEEN (15%) PERCENT OF THE GROSS SUM BID, AND CERTIFICATES OF INSURANCE covering personal injury, property damage and workmen's compensation and liability, all as set forth and required under said Contract No. 6205-S.

SECTION 6. That the costs, damages and expenses for the construction of said sewer line shall be collected from the property owners specially benefited thereby in the manner as now prescribed or as may be hereafter prescribed by law.

SECTION 7. Any Ordinance or part of any Ordinance that shall conflict with this Ordinance is hereby repealed to the extent of such conflict.
