

## ORDINANCE NO. 395

AN ORDINANCE OF THE BOROUGH OF MONROEVILLE, ALLEGHENY COUNTY, PENNSYLVANIA, ACCEPTING THE BIDS OF THE LOWEST RESPONSIBLE BIDDERS FOR THE CONSTRUCTION OF A FREE NON-SECTARIAN LIBRARY; AWARDING CONTRACTS TO SAID LOWEST RESPONSIBLE BIDDERS AND AUTHORIZING THE PROPER OFFICERS OF THE BOROUGH TO EXECUTE THE CONTRACTS WITH SAID BIDDERS.

WHEREAS, the Borough of Monroeville has heretofore prepared plans and specifications for the construction of a free, non-sectarian library in the Borough; and

WHEREAS, the Borough did advertise for bids for the construction of said free, non-sectarian library; and

WHEREAS, the following were found to be the lowest responsible bidders:

a. General Contract - G.A. Schneider & Son for the sum of \$110,700.00;

b. Electrical Contract - Tico Electric Company for the sum of \$18,773.00;

c. Heating and Air Conditioning Contract - James C. Eastley, Inc. for the sum of \$24,900.00;

d. Plumbing Contract - J. A. Kennedy for the sum of \$10,750.00;

WHEREAS, it is the desire of the Council of the Borough of Monroeville to accept said bids and award the contracts for the construction of said free, non-sectarian library.

NOW, THEREFORE, Be It Ordained By The Council of the Borough of Monroeville and it is hereby ordained and enacted by the authority of the same:

SECTION ONE: The bids of G. A. Schneider & Son, Tico Electric Company, James C. Eastley, Inc. and J. A. Kennedy are hereby accepted.

SECTION TWO: The Council of the Borough of Monroeville hereby awards contracts to the following bidders for the construction of the Monroeville Library in the amounts indicated:

(a) General Contract - G. A. Schneider & Son for the total sum of \$110,700.00.

(b) Electrical Contract - Tico Electric Company for the total sum of \$18,773.00.

(c) Heating & Air Conditioning Contract - James C. Eastley, Inc. for the total sum of \$24,900.00.

(d) Plumbing Contract - J. A. Kennedy for the total sum of \$10,750.00

**SECTION THREE:** Upon approval of the performance and labor and material bonds and all insurance contracts by the Solicitor of the Borough, the proper officers of the Borough of Monroeville are hereby authorized to execute contracts with the foregoing contractors in accordance with law.

**SECTION FOUR:** All Ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are hereby repealed to the extent of such conflict.
