

ORDINANCE NO. 406

AN ORDINANCE OF THE BOROUGH OF MONROEVILLE, ALLEGHENY COUNTY, PENNSYLVANIA, ACCEPTING THE BID FOR THE RECONSTRUCTION OF PORTIONS OF VALLEY VIEW DRIVE, THOMAS STREET AND CENTER STREET IN THE BOROUGH OF MONROEVILLE AND AWARDING A CONTRACT TO LAMPL ASPHALT PAVING CO., INC. FOR THE TOTAL SUM OF \$28,290.00 BASED ON UNIT PRICES IN SAID BID.

WHEREAS, the Council of the Borough of Monroeville has received bids for the reconstruction of portions of Valley View Drive, Thomas Street and Center Street in the Borough, after due advertisement in accordance with law; and

WHEREAS, Lampl Asphalt Paving Co., Inc. was found to be the lowest responsible bidder in the sum of \$28,290.00; and

WHEREAS, the said Council deems it to be in the best interest of the Borough to accept the bids and proceed with the contemplated work.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE COUNCIL OF THE BOROUGH OF MONROEVILLE, and it is hereby ordained and enacted by the authority of the same:

SECTION 1: The bid of Lampl Asphalt Paving Co., Inc. for the improvement of:

1. Valley View Drive between Quince Street and Greenleaf Drive for a distance of approximately 1100 feet, 22 feet wide with 8" soil cement base and 2 1/2" of ID-2 surface,

2. Thomas Street between Wilmerding Road and Hamilton Road for a distance of approximately 670 feet, 24 feet wide with 10" crushed aggregate base and 2 1/2" ID-2 surface,

3. Center Street between James Street and the cul-de-sac for a distance of approximately 1050 feet, 18 feet wide with 8" soil cement base and 2 1/2" of ID-2 surface, for a total sum of \$28,290.00 based on unit prices is hereby accepted.

SECTION 2: The proper officers are hereby authorized to enter into a contract with Lampl Asphalt Paving Co., Inc. in accordance with law.

SECTION 3: All ordinances or parts of ordinance in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.
