

ORDINANCE NO. 447

AN ORDINANCE EXPRESSING THE DESIRE OF THE CORPORATE AUTHORITIES OF THE BOROUGH OF MONROEVILLE, COUNTY OF ALLEGHENY, PENNSYLVANIA, TO INCREASE THE INDEBTEDNESS OF SAID BOROUGH BY THE AMOUNT OF ONE MILLION EIGHT HUNDRED THOUSAND (\$1,800,000.00) DOLLARS FOR SUNDRY PURPOSES, AND AUTHORIZING A PUBLIC ELECTION AND THE GIVING OF NOTICE THEREOF.

WHEREAS, it is necessary that the indebtedness of the Borough of Monroeville, County of Allegheny, Pennsylvania, be increased in the sum of One Million Eight Hundred Thousand (\$1,800,000.00) Dollars for the purpose of supplying funds for and toward the cost of extending the existing system of sanitary sewers within said Borough, including therein the laying out, extending, purchasing, acquiring, constructing and reconstructing of trunk line sewers, lateral sewers and all necessary appurtenances thereto, together with pumping stations if necessary or desirable therefor, as well as connections and lines outside of said Borough, and the acquisition of all lands, easements and rights-of-way necessary for the extension of said system, with the right to use funds derived from other sources for the aforesaid purposes together with or independent of the funds derived from such increase of indebtedness;

NOW, THEREFORE, BE IT ENACTED, and it is hereby enacted:

Section 1. That the corporate authorities of the said Borough of Monroeville, Allegheny County, Pennsylvania, in compliance with the Act of Assembly of the Commonwealth of Pennsylvania, approved the 25th day of June, 1941, P. L. 159, as amended, do hereby signify and express their desire to increase the indebtedness of the said Borough of Monroeville by the amount of One Million Eight Hundred Thousand (\$1,800,000.00) Dollars for the purpose of supplying funds for and toward the cost of extending the existing system of sanitary sewers within said Borough, including therein the laying out, extending, purchasing, acquiring, constructing and reconstructing of trunk line sewers, lateral sewers and all necessary appurtenances thereto, together with pumping stations if necessary or desirable therefor, as well as connections and lines outside of said Borough, and the acquisition of all lands, easements and rights-of-way necessary for the extension of said system, with the right to use funds derived from other sources for the aforesaid purposes together with or independent of the funds derived from such increase of indebtedness.

Section 2. That a public election be and the same is hereby authorized to be held on Tuesday, November 3, 1964 for the purpose of obtaining the assent of the electors of said Borough to said increase in the indebtedness of said Borough for the said purposes and that notice of said election be given to the electors according to law.

Section 3. That the proper officers certify to the County Board of Elections a copy of this ordinance and the form of the question to be submitted to the electors.
