

ORDINANCE NO. 519

AN ORDINANCE EXPRESSING THE DESIRE OF THE CORPORATE AUTHORITIES OF THE BOROUGH OF MONROEVILLE, ALLEGHENY COUNTY, PENNSYLVANIA TO INCREASE THE INDEBTEDNESS OF SAID BOROUGH BY THE AMOUNT OF THREE HUNDRED THOUSAND (\$300,000.00) DOLLARS FOR THE ACQUISITION, DEVELOPMENT, CONSTRUCTION AND EQUIPPING OF PARKS AND OTHER RECREATION PLACES, AND AUTHORIZING A PUBLIC ELECTION AND THE GIVING OF NOTICE THEREOF.

WHEREAS it is necessary that the indebtedness of the Borough of Monroeville, Allegheny County, Pennsylvania be increased in the sum of Three Hundred Thousand (\$300,000.00) Dollars for the purpose of supplying funds for and toward the cost of acquisition, development, construction and equipping of parks and other recreation places, with the right to use funds derived from other sources for the aforesaid purposes together with or independent of the funds derived from such increase of indebtedness;

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Borough of Monroeville, in Council assembled, as follows:

Section 1. That the corporate authorities of the Borough of Monroeville, Allegheny County, Pennsylvania, in compliance with the Act of Assembly of the Commonwealth of Pennsylvania approved the 25th day of June 1941, P.L. 159, as amended, do hereby signify and express their desire to increase the indebtedness of the said Borough of Monroeville by the amount of Three Hundred Thousand (\$300,000.00) Dollars for the purpose of supplying funds for and toward the cost of acquisition, development, construction and equipping of parks and other recreation places, with the right to use funds derived from other sources for the aforesaid purposes together with or independent of the funds derived from such increase of indebtedness.

Section 2. That a public election be and the same is hereby authorized to be held on Tuesday, May 17, 1966 for the purpose of obtaining the assent of the electors of said Borough to said increase in the indebtedness of said Borough for the said purposes, and that notice of said election be given to the electors according to law.

Section 3. That the proper officers certify to the Allegheny County Board of Elections a copy of this ordinance and the form of the question to be submitted to the voters.
