

ORDINANCE NO. 560

AN ORDINANCE OF THE BOROUGH OF MONROEVILLE AMENDING THE WAGES AND SALARIES ORDINANCE NO. 479 AND REPEALING CERTAIN PORTIONS THEREOF.

BE IT ORDAINED AND ENACTED by the Borough of Monroeville, in Council assembled, as follows:

Section 1. Section 1 of Article I of Ordinance No. 479, the Wages and Salaries Ordinance of the Borough of Monroeville, is hereby further amended by changing the compensation of the Borough Manager to read as follows:

Borough Manager \$1200.00 per month

Section 2. Section 2 of Article I of said Ordinance No. 479 is repealed in its entirety.

Section 3. Section 1 of Article II of said Ordinance No. 479 is further amended, by changing the monthly or hourly compensation of certain employee classifications, by adding additional pay steps in certain employee classifications, and by eliminating pay step F in the classification of Police Patrolman, as follows:

Section 4. Section 1 of Article II of said Ordinance No. 479 is further amended by adding the following additional employee classification under the heading of "Clerical, Fiscal and Administrative" and providing for the monthly compensation therefor:

Section 5. Section 1 of Article II of said Ordinance No. 479 is further amended by adding the following additional employee classification under the heading of "Recreation and Parks" and providing for the monthly compensation therefor:

Section 6. All employees of the Borough of Monroeville presently employed in any of the classifications listed in Section 3 of this Ordinance, shall be established in the lowest pay step within their present classifications, whether of a higher or lower ranking than their present pay step, as will result in an increase in their monthly compensation of not less than five (5%) percent of the monthly compensation under said Ordinance No. 479, as previously amended, to which they were entitled immediately prior to the effective date of this Ordinance.

Section 7. All employees whose pay step is changed as a result of the increase in compensation provided by Section 6 of this Ordinance, shall nevertheless retain such accruals of continuous service which they had prior to the effective date of this Ordinance, and shall be credited with such continuous service for the purposes of eligibility for advancement to their next higher pay step, if any.

Section 8. Sub-section 2 (g) of said Ordinance No. 479 is repealed in its entirety.

Section 9. The provisions of this Ordinance shall become effective as of January 1, 1967.

Section 10. Any ordinance or part of ordinance in conflict with any of the provisions of this ordinance is hereby repealed to the extent of such conflict.
