

ORDINANCE NO. 570

AN ORDINANCE OF THE BOROUGH OF MONROEVILLE AMENDING THE WAGES AND SALARIES ORDINANCE, NO. 479.

BE IT ORDAINED AND ENACTED by the Borough of Monroeville, in Council assembled, as follows:

Section 1. Section 1 of Article II of Ordinance No. 479, the Wages and Salaries Ordinance of the Borough of Monroeville, is hereby amended by substituting the following employee classifications and rates of compensation therefor under the heading of LIBRARY in lieu of all other classifications and rates of compensation heretofore provided under the heading of LIBRARY:

Section 2. Sub-section 2 (a) of Article II of said Ordinance is hereby amended to read as follows:

All new employees and all other employees entering in a classification for the first time shall, unless hereinafter otherwise indicated, enter such classification at the pay level of Step A. However, where exceptionally experienced or qualified personnel (other than Civil Service employees) are so hired or reclassified, the Borough Manager, the Library Board or the Mayor may, within their respective employee jurisdictions, establish such employee initially in Step A, Step B or Step C as the individual case may warrant.

Section 3. Section 10 of Article II of said Ordinance is hereby amended by changing item 6 thereunder to read:

- 6. Professional Librarian III

Section 4. Section 1 of Article III of said Ordinance is hereby amended to read as follows:

For purposes of this Article the term "full time employees" shall include the Manager and all employees compensated under Article II on a monthly basis. It shall not include however, Professional Librarians I, II or III under the jurisdiction of the Library Board. The Library Board shall by written order establish vacation policy and procedures for said Professional Librarians.

Section 5. Section 1 of Article IV of said Ordinance is hereby amended to read as follows:

For purposes of this Article the term "employees" shall include the Manager and all employees compensated under Article II on a monthly basis.

Section 6. Section 1 of Article II of said Ordinance is hereby amended by deleting the classification of "Dog Catcher" under the heading of PUBLIC SAFETY. All references to the employee classification "Dog Catcher" in any other provision or section of said Ordinance are hereby deleted.

Section 7. Section 1 of Article II of said Ordinance is hereby further amended by removing the employee classification "Animal Control Officer" from the heading of CLERICAL, FISCAL AND ADMINISTRATIVE EMPLOYEES and placing such classification under the heading of PUBLIC SAFETY employees, with the same rate of compensation as heretofore provided.

Section 8. The provisions of this amending Ordinance shall be effective as of January 1, 1967.

Section 9. Any Ordinance or part of Ordinance in conflict with any of the provisions of this Ordinance is hereby repealed to the extent of such conflict.
