

## ORDINANCE NO. 799

AN ORDINANCE OF THE BOROUGH OF MONROEVILLE AUTHORIZING  
AND DIRECTING THE CONSTRUCTION OF GRANDVIEW AVENUE  
EXTENSION SANITARY SEWER, CONTRACT NO. 7107-S; AND  
RICKEY DRIVE STORM SEWER, CONTRACT NO. 72-SS-1  
AND PROVIDING FOR THE EXECUTION OF SUCH CONTRACTS

BE IT ORDAINED AND ENACTED, by the Borough of Monroeville in Council  
assembled as follows:

Section 1. That a sanitary sewer line be constructed by the Borough of Monroeville to provide sanitary sewer service for an area of the Borough of Monroeville on Grandview Avenue Extension, in accordance with plans and specifications therefor known as Grandview Avenue Extension Sanitary Sewer Project Contract No. 7107-S.

Section 2. That a storm sewer be constructed by the Borough of Monroeville to provide storm sewer drainage for an area of the Borough near Rickey Drive in accordance with plans and specifications therefor known as Rickey Drive Storm Sewer Contract No. 72-SS-1.

Section 3. Upon the opening of the bids for the building of the Grandview Avenue Extension Sanitary Sewer Project Contract No. 7107-S, it appeared that the lowest reasonable bidder therefor was Rizzi Construction Company, Inc., whose total bid based on quantities contained in said contract, was One Hundred Fifteen Thousand Eight Hundred and Thirty Dollars (\$115,830.00).

Section 4. Upon the opening of bids for the building of Rickey Drive Storm Sewer Contract No. 72-SS-1 it appeared that the lowest responsible bidder therefor was Frank Mannella & Sons, whose total bid based on quantities contained in said contract was Seventeen Thousand Eight Hundred and Eighty Dollars (\$17,880.00).

Section 5. The proper officers of the Borough of Monroeville are hereby authorized and directed to enter into a contract with Rizzi Construction Company, Inc., for the construction of the said Contract No. 7107-S for the said sum of One Hundred Fifteen Thousand Eight Hundred and Thirty Dollars (\$115,830.00); and are hereby authorized and directed to enter into a contract with Frank Mannella & Sons for the construction of said Contract No. 72-SS-1 for the said sum of Seventeen Thousand Eight Hundred and Eighty Dollars (\$17,880.00). Upon the execution of the said contracts said contractors shall file with the Monroeville Borough Manager performance bonds, labor and materialmen's bonds, maintenance bonds and certificates of insurance, as required in the said contracts.
