

AN ORDINANCE OF THE BOROUGH OF MONROEVILLE AUTHORIZING AND DIRECTING CONTRACTS FOR ROAD RECONSTRUCTION, THE PURCHASE OF A UTILITY VEHICLE, AN ELEVATED PLATFORM TRUCK, COMMUNICATIONS EQUIPMENT, AND MEDICAL SUPPLIES.

BE IT ORDAINED AND ENACTED by the Borough of Monroeville in Council assembled as follows:

Section 1. The proper officers of the Borough of Monroeville are directed to enter into a contract with William H. O'Brien & Son, Inc., for earth moving for the Garden City Drive reconstruction Contract 73-R-2, pursuant to its low bid of June 5, 1973 of Eight Thousand Five Hundred and Twelve Dollars and Fifty Cents (\$8,512.50).

Section 2. The proper officers of the Borough of Monroeville are hereby directed to enter into a contract with Hi-Way Truck Sales for the purchase of one (1) 4-Wheel Utility Vehicle with trade-in pursuant to its low bid of June 5, 1973 of Three Thousand Three Hundred Forty-Six Dollars (\$3,346.00).

Section 3. The proper officers of the Borough of Monroeville are hereby directed to enter into a contract with American LaFrance for the purchase of an Elevated Platform Truck pursuant to its low bid of May 8, 1973 of One Hundred Twenty-Four Thousand Five Hundred and Sixty-Nine Dollars (\$124,569.00) as calculated by considering the value of certain exclusions.

Section 4. The proper officers of the Borough of Monroeville are hereby directed to enter into a contract with Motorola Communications & Electronics, Inc., for communications equipment pursuant to its low bid of June 5, 1973 of Twenty Six Thousand Ninety-Seven Dollars (\$26,097.00).

Section 5. The proper officers of the Borough of Monroeville are hereby directed to enter into a contract with Conaway M & M for medical supplies pursuant to its low bid of June 5, 1973 of One Thousand Four Hundred and Ninety-Seven Dollars and Thirty-Nine Cents (\$1,497.39) for ambulance related equipment and Two Thousand Five Hundred and Sixty-Four Dollars and Twenty Cents (\$2,564.20) for essential equipment for ambulances.
