

AN ORDINANCE OF THE MUNICIPALITY OF MONROEVILLE
AMENDING ORDINANCE NO. 993 KNOWN AS THE ADMINIS-
TRATIVE CODE AND ORDINANCE 1214 (AMENDING ORDINANCE
993)

BE IT ORDAINED and ENACTED, by the Municipality of Monroeville, in Council assembled as follows:

Section 1. Section 1 of Ordinance No. 1214 amending Section 1 of Article III of Ordinance No. 993 is hereby amended as follows:

Delete: "Civil Defense and Emergency Preparedness" from Responsibilities of Deputy Municipal Manager - Human Services

Section 2. Article III, Section 7 of Ordinance 993 shall read as follows:

- A. No Change
- B. The Department of Public Safety, under the direction of the Deputy Municipal Manager for Physical Services, shall be responsible for the performance of the following functions:
 1. The provision of police services which shall be divided into the following functional area under the supervision in ascending order of the Chief of Police, the Deputy Municipal Manager of Physical Services and the Municipal Manager:
 - a. patrol services division which shall be responsible for providing general uniformed police services throughout the Municipality, for providing full initial response to all incidents observed or assigned and for providing such other police services as assigned by Departmental supervisors.
 - b. investigative services division which shall be responsible for providing investigation of crimes, for responding to incidents observed, and for providing such other police services as assigned by Departmental supervisors.
 - c. special operations division which shall be responsible for providing targeted police services, special ordinance enforcement, for providing patrol replacement personnel, for providing police training, for responding to incidents observed, for community safety and community relations activities, for providing criminal records services, for providing animal control services, and for providing such other police services as assigned by Departmental Supervisors.

- d. the Administration Division shall be responsible for the supervising and control of all matters related to unit personnel, the formulation of departmental policy, regulations and procedures, the preparation and administration of grants and financial control as approved by the Manager, other projects as desired and designated, and the preparation of statistical and written information designed to assess the criminal threat and evaluate unit efficiency in alleviating that threat, and for overall operation of the police services.
