MUNICIPALITY OF MONROEVILLE

Allegheny County, Pennsylvania

AN ORDINANCE OF THE MUNICIPALITY OF
MONROEVILLE AUTHORIZING THE UNDERTAKING OF A
PROJECT BY THE MONROEVILLE HOSPITAL
AUTHORITY; AND REPEALING INCONSISTENT
ORDINANCES AND RESOLUTIONS.

WHEREAS, the Council of the Municipality of
Monroeville, Allegheny County, Pennsylvania, has heretofore
organized the Monroeville Hospital Authority pursuant to
Ordinance No. 1010 enacted May 11, 1976 (the "Ordinance"); and

WHEREAS, in Section 6 of the Ordinance, the Council
authorized the Authority to undertake the East Suburban Health
Center Project for Forbes Health System (the "System") and
determined that the health care facilities to be financed by
said Project would be desirable for the health and safety of the
residents of the Municipality of Monroeville; and

WHEREAS, in Section 8 of the Ordinance, as amended by
Ordinance No. 1273, enacted April 14, 1981, the Council
authorized the Authority to undertake an expansion project for
the East Suburban Health Center (now known as Forbes Regional
Health Center) and a replacement project for the System's
Columbia Health Center (now known as Forbes Metropolitan Health
Center), and determined that the provision of those health care
facilities by the Authority would be desirable for the health
and safety of the residents of the Municipality of Monroeville;
and

WHEREAS, the System proposes to undertake an equipment
acquisition program (the "Equipment Program") involving the
acquisition and installation of approximately \$19,500,000 of
fixed and movable equipment to be used in connection with the
provision of health care services at, and the administration of
the operations of, the System's Forbes Regional Health Center,
Forbes Metropolitan Health Center, Forbes Center for Gerontology
and Forbes Hospice; and

WHEREAS, the Authority has requested that this Council
empower the Authority to undertake as a project the financing of
all or a portion of the Equipment Program; and

WHEREAS, certain action is appropriate by this Council in order to authorize the Authority to proceed with consideration of the financing of the Equipment Program;

NOW, THEREFORE, BE IT ADOPTED, ENACTED AND ORDAINED by the Council of the Municipality of Monroeville, Allegheny County, Pennsylvania, that:


Section 1. Ordinance No. 1010, enacted May 11, 1976, as amended by Ordinance No. 1273, enacted April 14, 1981, is hereby further amended to add Section 9 as follows:

Section 9. The Authority is hereby authorized to consider, and if it determines in the exercise of its discretion, to undertake as a project the financing of the Equipment Program for the System, it being hereby determined that the financing of the Equipment Program is desirable for the health, safety and welfare of the residents of the Municipality of Monroeville and the areas served by the System's facilities.


Section 2. All prior ordinances or resolutions or parts thereof inconsistent therewith are hereby repealed.
