Section 205.1: No retail store, theatre or establishments selling services or products having television or video monitors, located within one thousand (1000) feet of a residential use, a church, a park, or a school, may sell, distribute or permit the distribution of adult literature or show or permit the showing of adult movies, adult films, adult shows, adult television or adult video.

- (a) For the purpose of this section, 205.1, the term "adult" with respect to literature, movies, films, shows, television or video is defined to mean such literature, movies, films, shows, television or video having as a dominant theme either an appeal to prurient interest in sex or violence.
- (b) Retail stores so located shall permit access to any retail area accessible to customers for inspection while the retail store is open for business and theaters so located shall permit access to its screen or screens or inventory of films for inspection while the theater is open for business.
- (c) Retail stores and establishments so located selling services or products having television or video monitors available for customers or patrons to use or view movies, films, shows, television or video shall (1) register with the zoning officer the number of television or video monitors within the establishment as well as the location where the same are or may be placed, (2) obtain a "video" permit for all televisions or video monitors over which movies, films, shows, television or video can be shown which permit shall state the number of televisions and video monitors within the retail store or establishment and describe the location of each, and (3) permit access to all places within the retail store or establishment for the purpose of inspection where such television or video monitors are or might be available for viewing by customers or patrons at any time when the establishment is open for business.
