ORDINANCE NO. 1728

AN ORDINANCE OF THE MUNICIPALITY OF MONROEVILLE, ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NOS. 450, 722, 901, 1246, 1297, 1334 AND 1648 REVISING THE USE CHARGES FOR OPERATION AND TREATMENT OF SANITARY SEWAGE IN THE MUNICIPALITY OF MONROEVILLE.

WHEREAS, effective January 22, 1991, the Allegheny County Sanitary
Sewage Authority charge for sewage treatment service will be increased
pursuant to a schedule of rates and charges adopted October 25, 1990; and
WHEREAS, the new rate increases the basic sewage service rate by 9

WHEREAS, it is estimated that the average customer uses 20,000 gallons per quarter and will pay approximately \$1.97 per quarter per year.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Municipality of Monroeville, in Council as assembled as follows:

SECTION 1. Section 18, 21 and 22 of Ordinance No. 450 as amended by Ordinance No. 722, 901, 1246, 1334 and 1648 is hereby amended as follows:

The following sewage rates shall be effective as of October 1, 1990:

1.) METERED WATER USERS:

cents for each 1000 gallons of water used; and

SEWAGE CHARGE

80 cents per 1000 gallons

68 cents per 1000 gallons

WATER USED PER QUARTER

For first 3,600,000 gallons

For excess over 3,600,000 gallons

2.) FLAT-RATE WATER USERS:

The following schedule of rates shall be applicable to water users whose water bills are based upon a flat rate as distinguished from those whose water bills are based upon meter readings:

All flat-rate water residential customers will be billed upon an equivalent residential unit basis (ERU). The average residential usage becomes the basis on which flat-rate residential water users are charged. The average residential usage is estimated at 20,000 gallons per quarter. Each residential flat-rate account will be billed for sewer service based upon this average unless proof is established that the customer's usage is less.

3.) OTHER WATER USERS:

The quantity of water used by water users other than those referred to in Subsections 1 and 2 above shall be estimated by the Authority, and each such water user's sewage charge shall be calculated by applying the schedule of rates set forth in said Subsection 1 to the estimated quantity.

4.) The customer service charge per quarter for those users identified in Subparagraphs 1 through 3 will be \$1.56 per bill.

SECTION 2. ADDITIONAL CHARGES FOR GARBAGE GRINDERS

A.) HOUSEHOLD GARBAGE GRINDERS

For each household grinder in a private dwelling unit, \$4.03 per quarter per unit.

B.) OTHER GARBAGE GRINDERS

For garbage grinders other than those referred to in Subparagraph A, \$67.20 per quarter per grinder of one horsepower capacity, and a

proportionately lower or higher charge per grinder of lesser or greater horsepower capacity.

SECTION 3. Any Ordinance or Resolution or part of any Ordinance Resolution in conflict herewith is hereby repealed to the extent of said conflict.
