ORDINANCE NO. 1737

AN ORDINANCE OF THE MUNICIPALITY OF MONROEVILLE  
TO PROVIDE FOR ADOPTION OF A BUDGET CONTAINING  
ESTIMATES OF PROPOSED REVENUES AND EXPENDITURES,  
AND TO PROVIDE FOR THE LEVY OF TAXES FOR EXPENSES  
OF SAID MUNICIPALITY FOR THE CALENDAR YEAR BEGINNING  
JANUARY 1, 1991.

BE IT ORDAINED AND ENACTED by the Municipal Council of the Municipality  
of Monroeville, Pennsylvania:

SECTION 1. That for the expenses of the government and its activities  
for the calendar year, beginning January 1, 1991 and ending December 31,  
1991, the amount in the following sections are hereby appropriated.

SECTION 2. That for the said calendar year there is hereby  
appropriated out of the General Fund the following:
