ORDINANCE NO. 1785

AN ORDINANCE OF THE MUNICIPALITY OF MONROEVILLE,
ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NOS.
1334, 1648, 1728, 1729, 1734 AND 1781 PROVIDING FOR
AN EFFECTIVE DATE OF JANUARY 1, 1992, FOR SEWAGE
RATE INCREASES; PROVIDE FOR THE ESTABLISHMENT OF
RESIDENTIAL AND COMMERCIAL SEWAGE CHARGES.

BE IT ORDAINED AND ENACTED by the Municipality of Monroeville, in Council assembled as follows:

SECTION 1. Section 1, of Ordinance No. 1781 is hereby amended to read as follows:

The following sewage rates shall be effective January 1, 1992.

ADDITIONAL CHARGES FOR GARBAGE GRINDERSA. Household Garbage Grinders

For each household garbage grinder in a private dwelling unit,
\$4.52 Per Quarter year Per Unit.

B. Other Garbage Grinders

For garbage grinders other than those referred to in A. above,
\$75.26 Per Quarter Year Per Grinder of one horsepower capacity, and
 a proportionately lower or higher charge per grinder of lesser or
 greater horsepower capacity.

SECTION 2. The aforesaid rates shall become effective on January 1,
 1992.

SECTION 3. All other Sections of the aforesaid referenced Ordinances
 shall remain unchanged in all other respects.


