Ordinance No. 1798

BE IT ORDAINED AND ENACTED by the Municipality of Monroeville, in Council assembled, as follows:

Section 1. Section 1 of Article I of Ordinance No. 479 of the Municipality of Monroeville is hereby amended to read as follows, and a new section 2 enacted:

"Section 1. The officers of the Municipality of Monroeville and their compensation shall be as follows:

- Deputy Mayor and Councilpersons . . .C-1
- Tax Collector (Real Estate)Compensation established
under existing ordinance
- Zoning Hearing Board Members.Z-1
- Municipal Manager47

Section 2. The following career employees of the Municipality of Monroeville shall be classified by function and by grade as follows, and their compensation shall be in steps as established by the grade and compensation as set forth in Section 3 below:

Section 2. Section 1 of Article II of said Ordinance 479 amended as follows:

Section 1. The following career employees of the Municipality of Monroeville shall be classified by function and by grade as follows and their compensation shall be in steps based upon experience and performance as established by the grade and compensation schedule as set forth in Section 3 below:

GENERAL - CLERICAL

Compensation expressed in Dollars Per Hour as established by the Police Department Civilian Employees (PDCE) and Municipal Clerical Workers (MCW) Bargaining Agreement.

GENERAL - PUBLIC SAFETY

Compensation expressed in Dollars Per Hour as established by the Police Department Bargaining Agreement.

GENERAL - PUBLIC WORKS & REFUSE

Compensation expressed in Dollars Per Hour as established by the Public Works/Sanitary Sewer Maintenance and Refuse Department Contracts.

GENERAL - LIBRARY

Compensation expressed in Dollars Per Hour as established by Monroeville Library Board.

GENERAL - CABLE T.V.

Section 2. The following part-time employees of the Municipality of Monroeville shall be classified by function and grade as follows and their compensation shall be as set forth in Section 3 below. Section 4. Any ordinance or part of ordinance in conflict with any of the provisions of this Ordinance is hereby repealed to the extent of such conflict.


Section 5. The provisions of this ordinance shall be effective as of January 1, 1992.
