SECTION 1. The fee schedule of the Department of Recreation and Parks attached hereto is hereby approved and shall be implemented, effective January 1, 1994.



Sand Volleyball Court, Rules and Regulations

The Department of Recreation and Parks shall administer the sand volleyball court areas in the Monroeville Recreation and Parks sites according to the following rules and regulations, under the authority granted by the Monroeville Municipality Council:

1. All citizens are welcome to use any vacant court for one hour according to the following:

Belaire (12 noon - 5 pm daily)
Bellwood (10 am - 8 pm (Summer)
10 am - 6 pm (September - May 1)

2. Permits can be acquired either at Belaire or the Recreation Offices for specific date and time according to the following:

Belaire (5-11 pm Memorial day to labor day)
Bellwood (10 am - 8 pm (Summer)
10 am - 6 pm (September - May 1)

3. Users of the court on "first come and wait your turn" basis shall vacate the court after an hour's play when others are waiting to play.

4. Publicized and scheduled in advance tournaments sponsored by the Department of Recreation and parks, may take precedence over "open court time".

5. Permit holders may "bump" persons occupying that court at any time designated according to their permit.

6. Portions of the tournament sponsored by the Department of Recreation and Parks, scheduled and publicized in advance, may take precedence during "Permit Time".

7. Only the Department of Recreation and Parks may conduct instruction and/or tournaments in those Municipal park areas.

8. Roster is required with fees as follows:

\$2.00/resident
\$3.00/non-resident

9. All on-site posted rules and regulations will be enforced or participants could be subject to removal.
