ORDINANCE NO. 1872

AN ORDINANCE OF THE MUNICIPALITY OF MONROEVILLE,  
ALLEGHENY COUNTY, PENNSYLVANIA, INCREASING THE  
NUMBER OF MEMBERS OF THE PLANNING COMMISSION OF  
THE MUNICIPALITY OF MONROEVILLE FROM FIVE (5)  
TO SEVEN (7) MEMBERS; PROHIBITING MORE THAN ONE  
(1) PERSON FROM EACH WARD OF THE MUNICIPALITY  
FROM SITTING AS A MEMBER OF THE PLANNING  
COMMISSION.

WHEREAS, Section 202 of the Municipality's Planning Code, as amended,  
53 P. S. Section 10202 provides that the governing body of any Municipality  
may create a Planning Commission which shall have not less than three (3)  
nor more than nine (9) members; and

WHEREAS, the Planning Commission of the Municipality of Monroeville  
currently has five (5) members and the Council of the Municipality of  
Monroeville desires to increase the members from five (5) members to seven  
(7) members so that there will be representation on the Planning Commission  
from each Ward of the Municipality; and

WHEREAS, Section 204 of the Municipality's Planning Code, as amended,  
53 P. S. Section 10204 provides that the governing body of any Municipality  
may increase the number of members of an already existing Planning  
Commission and that such increase shall be authorized by Ordinance.

NOW, THEREFORE, be it ordained and enacted by the Council of the  
Municipality of Monroeville and it is hereby ordained and enacted as  
follows:

SECTION 1. The Council of the Municipality of Monroeville, pursuant to Section 204 of the Municipality's Planning Code, as amended, 53 P. S. Section 10204, hereby increases the members of the Planning Commission of the Municipality of Monroeville from five (5) members to seven (7) members.

SECTION 2. It is the desire of the Council of the Municipality of Monroeville that no more than one (1) person from each Ward sit as a member of the Planning Commission of the Municipality of Monroeville.

SECTION 3. The existing members of the Planning Commission shall continue in their respective offices until the end of the term for which they were appointed, and the new members of the Planning Commission shall be appointed pursuant to Section 203 of the Municipality's Planning Code, as amended, 53 P. S. Section 10203, to four (4) year terms and that the terms of all members of the Planning Commission shall be fixed so that no more than two (2) shall be reappointed or replaced during any future calendar year.

SECTION 4. Any Ordinance or part of any Ordinance in conflict herewith is hereby repealed.
