ORDINANCE NO. 1894

AN ORDINANCE OF THE MUNICIPALITY OF MONROEVILLE, ALLEGHENY COUNTY, PENNSYLVANIA, ESTABLISHING A BUDGETARY RESERVE ACCOUNT PURSUANT TO SECTION 3156-b OF ACT 77 OF 1993 FOR THE DEPOSIT OF "PARTIAL YEAR" FUNDS DERIVED FROM THE 1% SALES TAX ENACTED BY THE COUNTY OF ALLEGHENY PURSUANT TO ACT 77 OF 1993.

WHEREAS, the Commissioners of the County of Allegheny have enacted a 1% sales tax subsequent to January 1, 1994, as established by Act 77 of 1993; and

WHEREAS, the Municipality of Monroeville will received "partial year" funds from the 1% sales tax enacted pursuant to Act 77 of 1993; and

WHEREAS, Section 3156-B of Act 77 of 1993 permits a municipality the discretion to adopt an ordinance establishing budgetary reserve accounts for the purpose of depositing into said accounts any "partial year" funds derived from the 1% sales tax adopted pursuant to Act 77 of 1993; and

WHEREAS, those funds deposited into the budgetary reserved accounts will not be subject to certain requirements established by Act 77 of 1993 in regard to tax relief measures but may be used for appropriate municipal purposes.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Council of the Municipality of Monroeville, and it is hereby ordained and enacted as follows:

SECTION 1. The proper Municipal Officials are hereby authorized to establish budgetary reserve accounts pursuant to Section 3156-B of Act 77 of 1993 and to deposit any "partial year" funds derived from the new 1% sales tax enacted by the County Commissioners of the County of Allegheny and received by the Municipality of Monroeville during calendar year 1994.


SECTION 2. The Council of the Municipality of Monroeville hereby authorized the proper Officials of the Municipality of Monroeville to expend any "partial year" funds received from the 1% sales tax adopted pursuant to Act 77 of 1993 to spend said funds for unanticipated fiscal emergencies as defined by the Council of the Municipality of Monroeville pursuant to Act 77 of 1993.

SECTION 3. Any ordinance, or part of an ordinance, in conflict herewith, is hereby repealed.


