Ordinance No. 1921

BE IT ORDAINED AND ENACTED by the Municipality of Monroeville, in Council assembled, as follows:

Section 1. The compensation of the **OFFICERS** of the Municipality of Monroeville shall be as follows:

Section 5. The compensation of **GENERAL-PUBLIC SAFETY** employees has been expressed in Dollars Per Hour as established by the Police Department Bargaining Agreement.

Section 6. The compensation of **GENERAL-PUBLIC WORKS & REFUSE** employees has been expressed in Dollars Per Hours as established by the Public Works/Sanitary Sewer Maintenance and Refuse Department Bargaining Agreement.

Section 7. The compensation of **GENERAL-LIBRARY** employees is established by the Monroeville Library Board.

Section 8. Any ordinance of part of ordinance in conflict with any of the provisions of this Ordinance is hereby repealed to the extent of such conflict.

Section 9. The provisions of this ordinance shall be effective as of January 1, 1995.


