ORDINANCE NO. 1987

AN ORDINANCE OF THE MUNICIPALITY OF  
MONROEVILLE, ALLEGHENY COUNTY, PENNSYLVANIA,  
VACATING A PORTION OF HOLT LANE IN THE JUNE  
PLACE PLAN OF LOTS

BE IT ORDAINED AND ENACTED, by the Municipality of Monroeville, in Council assembled as follows:

SECTION 1. That the portion of Holt Lane in the June Place Plan of Lots be vacated as below:

BEGINNING at a point, said point being south 1°04'00" west a distance of 5.174 feet from the northeasterly corner of property now or formerly Giacomo and Rosa Tolomeo, Block and Lot 638-P-177, Thence south 1°04'00" west a distance of 65.00 feet, Thence north 89°57'00" west a distance of 25.00 feet, Thence north 1°04'00" east a distance of 40.00 feet, Thence following a curve to the right at a radius of 25.447 feet an arc length of 39.521 feet to the place of beginning.

SECTION 2. The ownership of the ground hereby vacated shall revert to the property owners on accordance of with law.


SECTION 3. The Ordinance shall become effective in accordance with the provisions of the Monroeville Home Rule Charter, Article IV.


SECTION 4. Any Ordinance or part of an Ordinance in conflict with any of the provisions of this Ordinance is hereby repealed to the extent of such conflict.

ORDAINED AND ENACTED this 11th day of June, 1996.

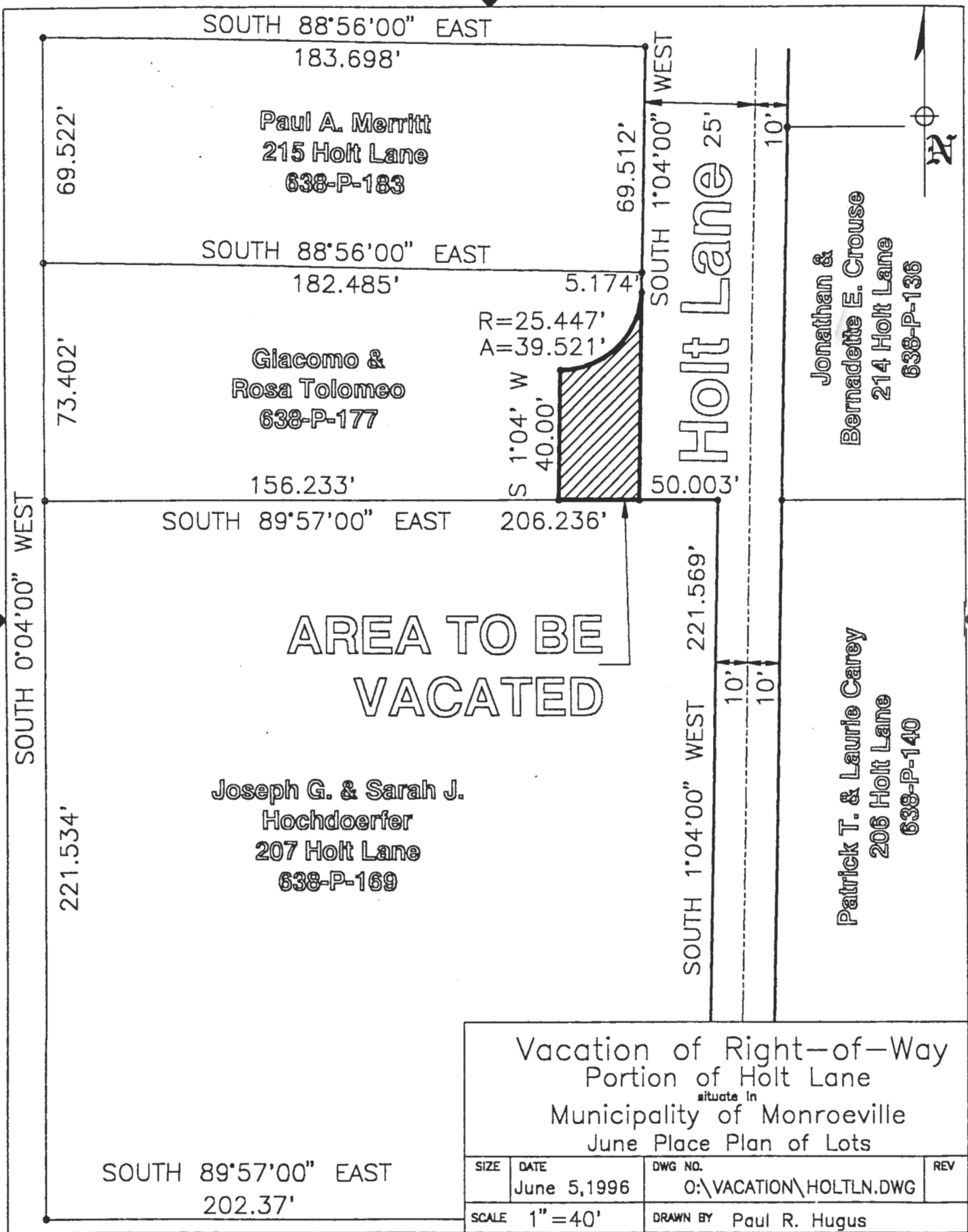


AREA TO BE


