ADDITIONAL CHARGES FOR GARBAGE GRINDERS

A. *Household Garbage Grinders*

For each house hold garbage grinder in a private dwelling unit:
\$9.24 per quarter year per unit - January 23, 1998.

B. *Other Garbage Grinders*

For Garbage grinders other than those referred in A. above: (Grinder of one horsepower capacity, and a proportionately lower or higher charge per grinder of lesser or greater horsepower capacity.)
\$153.90 per quarter per unit - January 23, 1998.

SECTION 2. The rates shall become effective on January 23, 1998.

SECTION 3. All other sections of the referenced Code shall remain unchanged in all other respects.



SECTION 4. Any part the Code conflicting with any provisions of the Amendment shall are hereby repealed to the extent of such conflict, provided, however, that no rights to the collection of back charges or interest accruing thereon under prior sections of the Code shall in any way be affected by this amendment.


