ORDINANCE NO. 2293

AN ORDINANCE OF THE MUNICIPALITY OF MONROEVILLE, ALLEGHENY COUNTY, PENNSYLVANIA, A HOME RULE CHARTER COMMUNITY, VACATING A PORTION OF OLD HAYMAKER ROAD IN THE DOEGE SUB-DIVISION.

WHEREAS, the Municipality of Monroeville has received requests to vacate a portion of Old Haymaker Road; and

WHEREAS, the Municipality of Monroeville deems it in the health, safety and general welfare of the municipality to vacate said portion of Old Haymaker Road.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED this 9th day of March, 2004, as follows:

SECTION 1. That portion of Old Haymaker Road in the Doege Sub-division described herein shall be vacated,

ALL that certain lot or parcel of ground situate in the Municipality of Monroeville, County of Allegheny and Commonwealth of Pennsylvania being bounded and described as follows, to wit:

BEGINNING at a point, said point being the Northeast of the property now or formerly John and Mary Hainley, Block and Lot 855-P-12, thence North 75° 23' 00" East a distance of 50.00 feet, thence north 14° 37' 00" West a distance of 53.28 feet, thence North 53° 31' 00" West a distance of 56.65 feet, thence North 143° 31' 00" East a distance of 5.00 feet, thence North 53° 31' 00" West a distance of 29.52 feet, thence South 14° 37' 00" east a distance of 124.00 feet to the place of beginning.

SECTION 2. Attached hereto incorporated herein as Exhibit AA≅ is a drawing showing that area of Old Haymaker Road to be vacated.

SECTION 3. The ownership of the ground hereby vacated shall revert to the property owners in accordance with the law.

SECTION 4. The Solicitor is directed to prepare any legal documents necessary to effectuate the vacation of that portion of Old Haymaker Road in the Doege Sub-division and record the same at the Recorder of Deeds office in Allegheny County, Pennsylvania.

SECTION 5. All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed.

SECTION 6. If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality, or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Board of Commissioners that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.



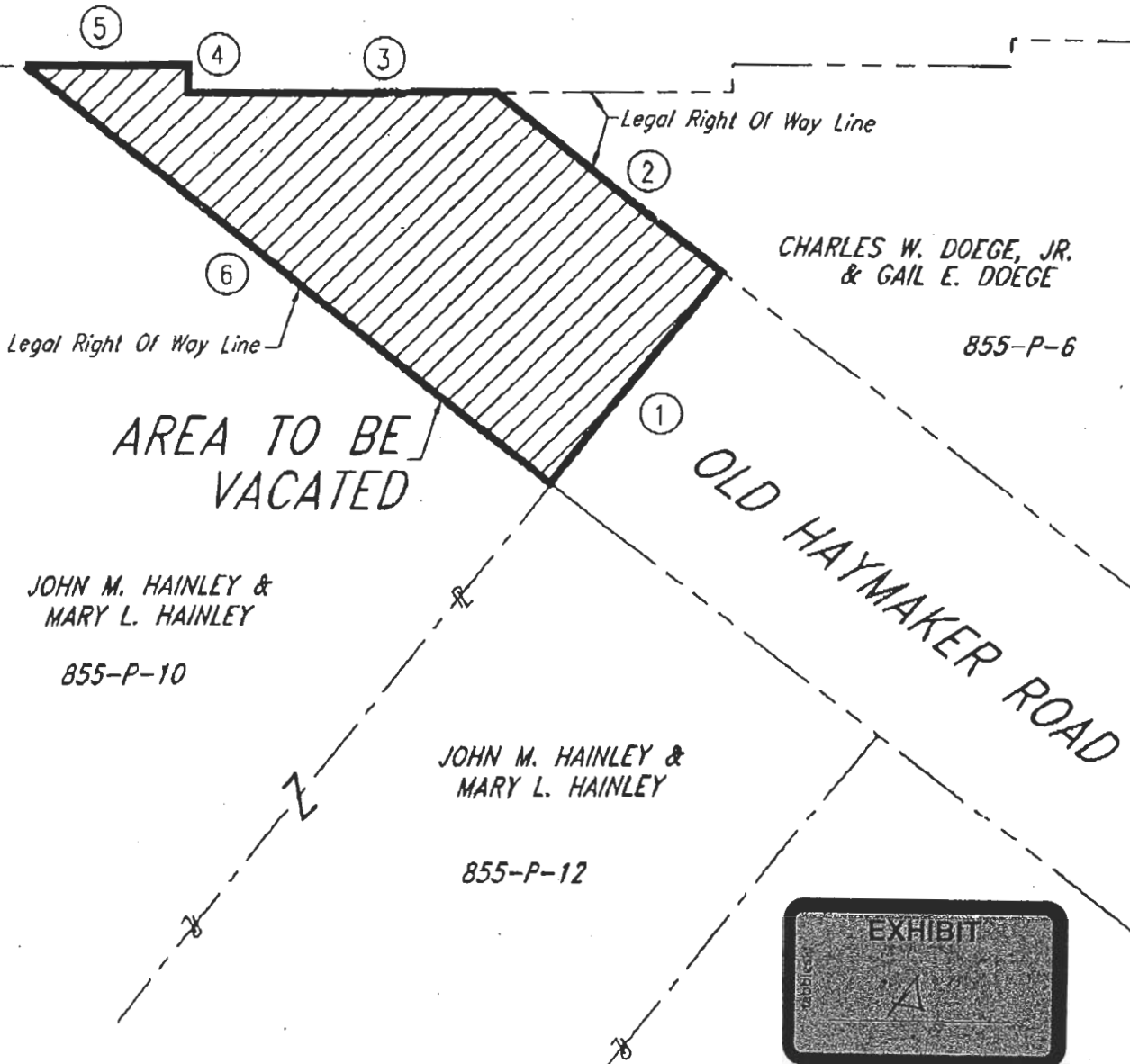

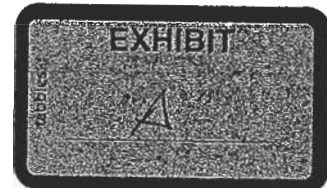
AREA TO BE VACATED
