

ORDINANCE NO. 2356

**AN ORDINANCE OF THE MUNICIPALITY OF
MONROEVILLE AMENDING ORDINANCE NO.
848, REGULATING TRAFFIC, PARKING, AND
IMPOUNDING OF VEHICLES.**

NOW THEREFORE, on December 13, 2005, BE IT ORDAINED and enacted by the Council of the Municipality of Monroeville, and it is hereby ordained and enacted as follows:

Section 1. Article II, Section 6, of Ordinance 848 is revised to read as follows:

The following highways are established as through highways, thus authorizing stop or yield signs to be erected facing traffic approaching every intersection with the through highway except for those intersections with traffic signals, or with exceptions or modifications as indicated below. Every driver of a vehicle approaching a stop or yield sign authorized by this section shall stop the vehicle or yield right-of-way as required by Section 3323(b) or 3323(c) of the Vehicle Code, as the case may be, and shall not proceed into or across the through highway until he/she has followed all applicable requirements of that section of the law:

Section 2. Article II, Section 6, of Ordinance 848 is amended by the addition of the following through highways:

<u>Highway</u>	<u>Designated Portion</u>
1. Golfridge Drive	At both intersections with Mallard Drive.
2. Mallard Drive	At intersection with Jefferson Court.
3. Blue Grass Circle	Stroschein Road west to Stormwater Pond Access Rd.
4. Berkley Way	Northern Pike south to clubhouse access road.
5. Tilbrook Road	Macbeth Drive to Grandview Drive.

Section 2. Article II, Section 7, of Ordinance 848 is amended by the addition of the following single stop intersections:


<u>Stop Highway</u>	<u>Direction of Travel</u>	<u>Through Highway</u>
1. Golfridge Drive	Northbound	Old Frankstown Road
2. Mallard Drive	Eastbound	Golfridge Drive (Northerly)
3. Mallard Drive	Eastbound	Golfridge Drive (Southerly)
4. Jefferson Court	Southbound	Mallard Drive


