**ORDINANCE NO. 2428**

**AN ORDINANCE OF THE MUNICIPALITY OF MONROEVILLE,  
ALLEGHENY COUNTY, PENNSYLVANIA AMENDING ORDINANCE NO. 848,  
OF THE MUNICIPALITY OF MONROEVILLE AMENDING ARTICLE III,  
SECTION II TO MAKE THE SOUTH SIDE OF BROADWAY BOULEVARD  
(STATE ROUTE 130) STARTING APPROXIMATELY 250 FEET EAST OF  
STEELE STREET AND ENDING AT OPPOSITE SIDE OF VALLEY ROAD AT  
THE MUNICIPALITY OF MONROEVILLE / NORTH VERSAILLES TOWNSHIP  
MUNICIPAL LINE FOR A DISTANCE OF 525 FEET, A NO TRUCK TRACTOR  
SEMI-TRAILER PARKING AT ANY TIME ZONE.**

**NOW THEREFORE**, be it ordained this 9<sup>th</sup> day of September, 2008 by the  
Council of the Municipality of Monroeville as follows:

SECTION I: Article III, Section II is amended to make the South side of State  
Route 130 a “No Truck Tractor Semi-Trailer Parking at Any  
Time” zone as described above..

SECTION II: Any person or entity that violates the terms of this Ordinance shall  
be punishable by fines and penalties as more fully set forth in  
Ordinance No. 848, as amended. Said Ordinance is hereby  
affirmed and adopted by the terms and conditions of this  
Ordinance.

SECTION III: If any sentence, clause, section or part of this Ordinance is for any  
reason found to be unconstitutional, illegal or invalid, such  
unconstitutionality, illegality or invalidity shall not affect or impair  
any of the remaining provisions, sentences, clauses, sections or


parts of this Ordinance. It is hereby declared as the intent of the Council of the Municipality of Monroeville that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.

SECTION IV: Any ordinance or part of any Ordinance in conflict herewith, is hereby repealed to the extent of that conflict.

**ORDAINED** and **ENACTED** this 9<sup>th</sup> day of September, 2008.

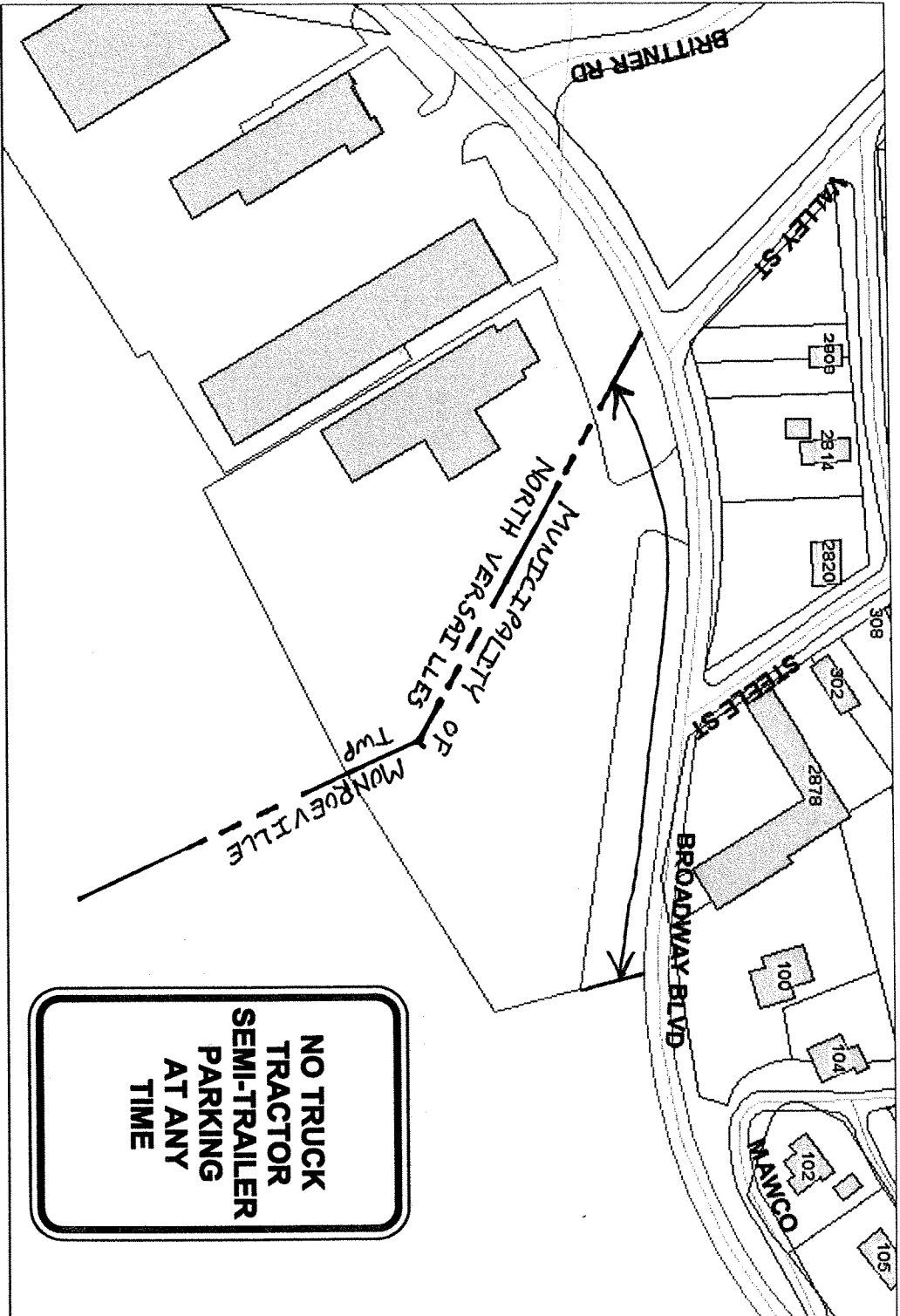
