WHEREAS, the Municipality and the Monroeville Police Wage Policy Committee have negotiated a revision to the current collective bargaining agreement; and


WHEREAS, the Municipality and the representatives of the Monroeville Police Wage Policy Committee have reduced the revisions to writing and attached a copy hereto; and

**MEMORANDUM OF UNDERSTANDING
BETWEEN
MUNICIPALITY OF MONROEVILLE
AND
MONROEVILLE POLICE DEPARTMENT WAGE POLICY
COMMITTEE**

The Municipality of Monroeville has requested that Monroeville Police Department employees covered by the Collective Bargaining Agreement pursuant to Ordinance 2410 covering the years January 1, 2008 until December 31, 2010 forgo the following provisions of this contract for economic hardship conditions:


- Section 15.4.4 Wages 0% January 1, 2010
- Section 15.4.4.4 Cost of Living Adjustment (COLA) suspended for 2010

In return the Municipality of Monroeville agrees to not ~~involuntarily~~^{MBS/} reduce the current work force and to extend the current contract under the existing terms and conditions including the original terms of Section 15.4.4 Wages and Section 15.4.4.4. Cost of Living (COLA) beginning January 1, 2011 and ending December 31, 2011.
