ORDINANCE NO. 2539

**AN ORDINANCE OF THE MUNICIPALITY OF MONROEVILLE
REPEALING ORDINANCE NO. 2411 AND HEREBY
DISSOLVING THE MONROEVILLE REDEVELOPMENT
AUTHORITY**

WHEREAS, Council for the MUNICIPALITY OF MONROEVILLE, pursuant to Section 35 P.S. 1704.1 is desirous of dissolving the Monroeville Redevelopment Authority; and

WHEREAS, Council for the MUNICIPALITY OF MONROEVILLE believes that the function of the Redevelopment Authority of Monroeville can be more properly carried out by the Allegheny County Authority, and there is no longer a need for the Authority created by the MUNICIPALITY OF MONROEVILLE; and

WHEREAS, no notes, bonds, debts or other contractual obligations have been incurred by the Monroeville Redevelopment Authority.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by Council for the MUNICIPALITY OF MONROEVILLE, as follows:

SECTION 1: Ordinance No. 2411 is hereby repealed.

SECTION 2: The Monroeville Redevelopment Authority is hereby dissolved pursuant to Section 35 P.S. 1704.1, as the functions of said Authority can be more properly carried out by the Allegheny County Authority, and there is no longer any need for the

Authority. Further, no bonds, debts or other contractual obligations have been incurred by the Monroeville Redevelopment Authority.


SECTION 3: the proper Municipal officials are hereby authorized and directed to comply with the necessary filings with the Commonwealth of Pennsylvania to perfect this dissolution.

SECTION 4: All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed.

SECTION 5. If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality, or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Municipality of Monroeville that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.
