**ORDINANCE NO. 2617**

**A ORDINANCE OF THE MUNICIPALITY OF MONROEVILLE,  
ALLEGHENY COUNTY, PENNSYLVANIA APPROVING AN AMENDMENT  
TO THE ARTICLES OF INCORPORATION OF THE MONROEVILLE  
MUNICIPAL AUTHORITY INCREASING THE TERM OF EXISTENCE OF  
THE AUTHORITY**

**WHEREAS**, the MUNICIPALITY OF MONROEVILLE (the "Municipality"), of Allegheny County, Pennsylvania, adopted an Ordinance to establish the Monroeville Municipal Authority (the "Authority"), Allegheny County, Pennsylvania, on October 10, 1949, pursuant to the Municipality Authorities Act of 1945, as amended (the "Act"); and

**WHEREAS**, the Authority has a corporate life which expires March 29, 2048; and

**WHEREAS**, the Authority has had, as its primary purpose, the management of a water treatment and distribution system and sanitary sewage collection and treatment within the Municipality; and

**WHEREAS**, the Authority has had, as its primary purpose, the management of a water and distribution system and sanitary sewer treatment and transportation system within the Municipality, but now the Authority desires to make improvements to a water distribution system expected to be conveyed to it by the Westmoreland County Municipal Authority; and

**WHEREAS**, the Board of the Authority has adopted an Ordinance at its meeting of April 28, 2014 requesting the approval of the Municipality of amendments to its Articles of Incorporation in order to increase the term of existence of the Authority (a copy of said ORDINANCE is attached hereto marked Exhibit "A" and incorporated herein); and

**WHEREAS**, the Municipality desires to aid and cooperate with the Authority in accordance with its wishes.

**NOW, THEREFORE, BE IT RESOLVED**, by the Council of the MUNICIPALITY OF MONROEVILLE, as follows:


- SECTION 1:** The Articles of Incorporation of the Authority shall be amended as follows:  
The term of existence of the Authority shall be extended to that date which is fifty (50) years from the date of approval of these Articles of Amendment by the Secretary of the Commonwealth.
- SECTION 2:** The Mayor and President of Council are hereby authorized and directed to execute all things necessary and proper to effectuate the amendment to the Articles, and the Municipality Secretary is hereby authorized and directed to affix the seal of the Municipality to any such executions, and attest such signatures of the Mayor and President.
- SECTION 3:** All Articles, Amendments, Ordinances or parts thereof that are inconsistent with this Ordinance are hereby repealed.
- SECTION 4:** If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Municipality Council that this Ordinance would have been adopted had such unconstitutional, illegal or invalid


sentence, clause, section or part thereof not been included herein.
